Qualitative Research Methods (M.Phil. Compulsory Course)

Total Credits: 4

Objectives of the Course

This course offers a general introduction to the qualitative methods in social research. As a general course, it covers a number of issues including philosophical traditions, research design, fieldwork, data collection, data analysis, and reporting. There are several ways of doing qualitative research and we will have moments when we reflect on them, but this course particularly focuses on the field research tradition. This course emphasizes student involvement in a series of research projects including research proposal development, data collection, data analysis, and reporting. At the end of the semester, it is expected that students will have a good idea about the types of questions suitable for qualitative research, will be able to develop a qualitative research proposal, and will be able to independently conduct their field research.

Unit I: Philosophical Traditions

This unit grounds contemporary qualitative research practices in philosophical traditions. This unit, in particular, examines the questions such as the notion of science and the relationship between epistemology, theory, methodology, and methods.
