Aims of the Course

The course will provide students with a complete understanding of research methodology adopted in conducting legal research. Also, the course will introduce students to the significant methods used in the research in international law. The course will also focus on developing the legal writing skills of students in order to enable students to write concisely and precisely.

Overview of the Course

This course will expose students to methods of legal research and legal writing. The course aims to impart training on legal research to students. Students are expected to undertake substantial work outside of class in the forms of targeted readings related to their project, identifying a research question and organizing their research strategy.

The course involves teaching of 12 weeks with four hours of teaching per week. The teaching learning methodology will include lectures, group discussions, individual exercises; and, class presentations

Course Structure

Week 1

Introduction to the Course; nature, scope, aims and significance of legal research. How is legal research difference from research in social sciences? How can legal research impact policy research?

Week 2

Introduction to the major methods of international legal scholarship today – positivism, new haven school (policy-oriented jurisprudence), critical legal studies, feminist approaches to international law, international law and international relations, law and economics, third world approaches to international law (TWAIL)

Weeks 3 and 4

Different methods for legal research – doctrinal research, non-doctrinal research, socio-legal research, empirical research and comparative law research methodology

Week 5

Research Design – developing a workable hypotheses, finding a research problem, developing a synopsis, literature review and its significance, developing proper structure of the research, identifying the time-table for research to be performed.

Week 6

Legal Writing – the significance of legal writing; how to structure a research and how to frame an abstract and write clearly and concisely

Week 7

Introduction to different types of legal writing such as research proposal, research papers, short articles and commentaries, case comments, review articles including book review and newspaper articles. The forthcoming weeks will discuss each of these forms of legal writing

Week 8

How to write a research proposal? What are the important elements of a research proposal; how to tailor the research proposal based on the target audience. The discussion will be based on practical work by the students.

Week 9

How to write a short article or commentary? What factors should be kept in mind? The significance of target audience in writing a short article or commentary.

Week 10

How to write a case comment or a case note? How is writing a case comment or case note different from other forms of legal writing like writing short articles or commentary? What weightage should be given to analysis of facts and analysis of law in a case comment? Is there a difference between writing case note on a domestic court decision and between a decision rendered by an international tribunal?

Week 11

How to write review articles or a book review?
